Bulgaria Labor Laws And Regulations According to Art. 326(2) of the Labour Code, the notice period varies depending on whether the working contract is permanent and temporary. In case of a permanent contract, the law in Bulgaria provides for a notice period of 30 days, as long as the parties have not previously agreed on a longer period (that shall not exceed 3 months). Labour law in Bulgaria - Wikipedia The first statute enacted in Bulgaria aimed to protect children and women in the workplace and was adopted in 1905. The statute regulated the minimum working age, working hours, holidays and maternity leave. Later, other statutes were

enacted regarding labour law. In 1907, the Labour Inspectorate was established.
