The U.S. Court of Appeals affirmed a court ruling that when there's no agreement between a buyer and a seller to allocate any part of the purchase price to a covenant, the seller could treat all proceeds as capital gain. clause under which one party (usually an employee) agrees not to enter into or start a similar profession or trade in competition against another party (usually the employer). Some courts refer to these as "restrictive covenants". Non-compete clause - Wikipedia A common misconception among employers is that covenants not to compete are enforceable against an employee so long as the covenant is not overly broad or unduly restrictive on the employee, i.e., it is limited in time, place, and scope. In most states, this belief would be correct. However, in California, the law holds quite to the contrary and virtually all such covenants not to compete are unenforceable.
