It does not matter where you are married. Only one of you has to meet the DC residency requirement. One can only ask for alimony and distribution of marital property in your divorce case. Make enough copies of your documents for your spouse and be sure to keep at least one copy for

yourself. The spouse filing the initial Complaint must provide a copy to his or her spouse. This is known as service of process. Then, the case will be filed as an Uncontested Divorce and a hearing date will be set.
